No stand is allowed to be cleared partly or completely before end of the fair. At infringements the organizer is entitled to declare a contractual penalty amounting to EURO 250,00 against the exhibitor and/or to prohibit the concession of the exhibitor for the following event.

5. Application

For exhibitors which will apply until June 30th 2011 the stands of the previous year will be reserved. After June 30th 2011 the stands will be assigned in accordance of the time of application. Desired stands can be considered. An entitlement on these can not be granted. Closing date for applications is December 31st 2011. At possibly delayed application a claim on inclusion into the official journal of exhibitors is not existing.

Advantage of early application: At complete application until June 30th 2011 the above mentioned rental price is reduced by EUR 10/m². Exhibitors are obliged to buy-off the communication package at a price of **EURO 120.00** (see point 12 of the participation conditions).

An electrical connection will be installed on every stand, the costs on this amount to **EURO 95.00**.

At two-storeyed construction 50% of the rental price for the ground area is charged for the walkable area. A two-storeyed construction can be allowed only in agreement with the fair authorities and the Building Official Dortmund.

An electrical connection will be installed on every stand, the costs on this amount to **EURO 95.00**.

At two-storeyed construction 50% of the rental price for the ground area is charged for the walkable area. A two-storeyed construction can be allowed only in agreement with the fair authorities and the Building Official Dortmund.

Co-exhibitors: The exhibitors are not entitled to sublease or to leave in an other way the leased stand completely or partly to third persons without approval of the organizer. The inclusion of a co-exhibitor is to be announced in writing by the exhibitor to the organizer in advance. In this case the exhibitor is charged with a co-exhibitor fee of **EURO 250.00** per co-exhibitor. This fee can be charged by the organizer belated also.

Co-exhibitors are obliged to buy-off the communication package at a price of **EURO 120.00** (see point 12 of the participation conditions).

The rental price includes: Lease of the stand area during installation, duration and dismantling; general custody of the exhibition halls; general illumination of the exhibition halls; general cleaning of the walks; exhibitors contribution for the exhibitors evening (without visitors) on Wednesday, February 15th 2012. Design and furnishing of the stand is the matter of the exhibitor (see point 9 of participation conditions).

All prices are to be read plus VAT.

7. Terms of payment

The complete stand rental will be charged to the exhibitor with the stand confirmation. The invoices are to be paid without discount. All payments are to be conducted without charges and in EURO with indication of the invoice number. At belated amendments of the invoice address, which are in the responsibility of the exhibitor, the organizer will charge a handling fee of EUR 40.00. A claim on the granted stand area is existing after complete payment of the invoices only. The evidence of payment is to be provided by the exhibitor.

8. Exhibitor passes

The exhibitor is granted with passes free of charge in the following amounts:

9. Stand design

14. Insurance

The exhibitor is obliged in principle to take care for a sufficient insurance cover. The conclusion of a trade fair insurance to cover the risk of transportation and stay is recommended.

15. Rules

Flooring, hall walls, columns, installation- and fire protection equipments as well as other firm hall fixtures must not be glued, nailed, painted or damaged in any other way. Damages are at the expense of the exhibitor and will be charged.

Providing of meals and beverages for the immediate consumption **against payment** is prohibited.

Exhibitor passes may only be given to the exhibitors employees active on the stand.
